3. The resources (Library) and manpower (Students of Languages and Social Sciences, NSS, Cultural Department and teaching faculty) will be shared as per the convenience of both the parties without disturbing the academic calendar of 1st party.
4. All the legal permissions regarding execution of project/activity will be looked after by 2nd party.
5. The 1st party will be involved only in the activities/projects which are related to aims and objectives of Rayat Shikshan Sanstha, Satara.
6. If 1st and 2nd party will work together on funded projects then 2nd party will be liable to give the first preference to the students and faculty of the 1st party.

7. If the collaborative project/activity results into any product or invention, then both parties will be equally benefited by the IPR.

8 In any collaborative project/activity, 1st party will not be involved in any financial transactions and settlements.

9. This Agreement shall enter in force upon signature by both parties and shall remain in force for 5 (five) years unless terminated earlier by either party upon one month of written notice to the other party. Each party may propose to the other amendments to this Agreement in writing. Such amendments shall be established by mutual written agreement of the parties.




